## **POLICIES:**

The client hereto agrees as follows:

- 1) Austin Dog Walker (hereinafter referred to as "ADW") and its employees agree to provide services stated in this contract in a reliable and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives any and all claims against ADW or its employees, unless arising from negligence on the part of ADW.
- 2) ADW or its employees shall not be held responsible for the loss, injury, death, or actions of any pet that the client has let outside or has instructed ADW to allow outside while walker is not there. This includes pets with doggie doors and outdoor pets.
- 3) The client understands that all pets (where appropriate) must have a veterinarian and must be up to date on the rabies vaccination (proof of vaccination required by ADW).
- 4) The client understands that all pets must have a collar with a rabies vaccination tag, and an ID tag (if dog has a "chip" or tattoo for identification, then ID tag requirement will be waived).
- 5) ADW does not promote off leash walking and strictly adheres to all local laws. Off leash walking is only permitted after an evaluation period and only in leash-free locations designated as such by Travis County and the City of Austin. All dogs in the care of ADW are walked on leash for the entirety of their first trip with us and based upon performance, may or may not continue to be on a leash for future walks.
- 6) ADW does not diagnose, prognose, or make therapy decisions, nor does it offer veterinary services. Any veterinary/medical concerns will be referred to the closest veterinarian or emergency medical hospital.
- 7) ADW does not accept aggressive animals.
- 8) ADW will not walk unruly or untrained dogs or dogs that choke themselves on their leash.
- 9) ADW will not accept time specific calls as we can not guarantee specific times accurately. A two hour window is acceptable.
- 10) ADW will require 2 keys to the client's home and is not held responsible for any keys that the client has mailed or asked ADW to mail.
- 11) ADW reserves the right to deny service or terminate service due to safety or financial concerns, or inappropriate or uncomfortable situations.
- 12) ADW reserves the right to take pet(s) to vet if necessary. Client is responsible for all applicable charges.
- 13) ADW requires you to have a secondary responsible party to take care of your pet(s) in the event of unforeseen circumstances such as illness or death to either dog walker or self and in the event of inclement weather or a natural disaster. It is best your emergency contact is a neighbor so they can reach your home.
- 14) Payment is expected before services are rendered. Payment is accepted in the following forms; check, cash, or online via PayPal transaction. In the event of a returned check, the client will pay the entire service fee and an additional \$30.00 NSF fee promptly via cash or money order. In the event of additional unforeseen visits or other costs (such as food, supplies, or vet fees), payment is expected upon completion of services or a late charge of \$20 will be applied.
- 15) Cancellations of scheduled services must be received 2 hours before arrival to receive credit.
- 16) The client understands that all photos and/or videos taken of client's pet(s) by ADW and its employees and licensed vendors are the property of ADW and that ADW has the right to publish same photos and/or videos of client's pet(s) on the ADW website or any other electronic media such as YouTube, MySpace, etc. or in print form.
